A Look on the Legal Side


Dennis Badagliacco, who is one of three members serving on the Legal Advisory Board of the NAR, as are other prominent members of AREA: **Diana Bull** and **Patti Lawton**, who is Chair, made the following presentation about current legal considerations facing the NAR.

Staging and potential false advertising. Just a warning to beware that representing something via virtual advertising has inherent risks.

A broker with 13 closings in escrow files bankruptcy. The Judge rules that the escrow checks belong to the bankruptcy court. (Sometimes, you just can't win while losing.)

Yelp is sued to force the disclosure of who gave specific ratings. Their sources remain sacrosanct by ruling of the presiding judge.

A Wine Tasting Room Partnership sells the business, which is later heavily damaged by floods during a catastrophic rain storm. The buyers were unaware this could be an issue. They sold it direct without an agent. The Court rules in favor of the Sellers, as they were not contractors and were not required to fill out a property owner's disclosure. (Several members noted that SPQ's, SPUDS, whatever they are called, are governed by each state, so different may rules may apply. This particular case emanated in California.)
