

A Look on the Legal Side

with Dennis Badagliacco

Dennis Badagliacco, who is one of three members serving on the Legal Advisory Board of the NAR, as are other prominent members of AREA: **Diana Bull** and **Patti Lawton**, who is Chair, made the following presentation about current legal considerations facing the NAR.

Dennis Badagliacco then gave his report:

- 1. The Good news is the NAR has approved a master insurance policy including cyber protection for first, second and third parties and is preparing a "cheat sheet" to show the elements, which should be in any such policy for individual firms.
- 2. The Santa Barbara Board of Realtors with the help of Pacific Legal Foundation is suing the City of Santa Barbara, which has imposed an automatic house inspection \$475 to occur 5 days after the opening of an escrow. The claim asserts that the City is then able to make arbitrary decisions regarding issues without due process or a warrant for a search thus, potentially, violating the privacy rights of those being inspected.
- 3. The Federal Government in 1854-55 made an agreement with certain Native American Tribes to insure future unimpeded access through ingress and egress to salmon stocks. The indian tribes claim the culverts over highways, bridges, rail

- ways and other public works, all of which were built by the Federal Government, are impeding the flow of salmon. The 9th Circuit court has ruled that the State of Washington is liable to the tribes for these actions and the state is liable for approximately \$2 billion in retribution. An appeal is underway.
- 4. PDF Filler is now scrapings ZIP Logic forms and documents from Texas as well as California and then selling the forms to third parties at a greatly reduced rate. The third-party users are also able to modify, what appears to be a standard contract used by all others. Texas is suing PDF Filler and NAR is contributing \$300,000 to Texas to help with case.
- 5. South Carolina has a standard arbitration clause in its agreements. One party does not like the outcome of the verdict. South Carolina, with help from NAR is joining an Amicus Brief to uphold the Arbitration clause. Most States have a similar clause. It is imperative the Arbitration Clauses be upheld.
